The Federal Public Defender, Northern District of California is accepting applications for a termed, full-time Research & Writing Specialist ("R&W Attorney"). This position will begin upon hire date and will end September 30, 2018. The Defender operates under the authority of the Criminal Justice Act, 18 U.S.C. § 3006A, to provide defense services in federal criminal cases. JOB DESCRIPTION: Duties include providing support to the Federal Defender and Assistant Federal Public Defenders through legal research and writing. The R&W Attorney will research and draft appellate briefs and habeas petitions, assist in briefing pretrial and *in limine* motions, draft proposed jury instructions, research and draft legal arguments for sentencing memoranda, and will provide other assistance to trial counsel.

The Research and Writing Attorney is not authorized to appear in court on behalf of the client.

REQUIREMENTS AND QUALIFICATIONS: Applicants must:

- Be a law school graduate and member of the State Bar of California, another State Bar, or the Bar of the District of Columbia;
- Have the ability to identify and analyze legal issues from lengthy and complex records;
- Write clearly and concisely;
- Possess excellent research skills;
- Possess demonstrated expertise in computer-assisted legal research;
- Have demonstrated experience analyzing complex federal criminal law and sentencing issues:
- Be proficient in Microsoft Word 2013 or Word 2016.

This is a full-time termed position. Salary is based on the Judicial Salary Plan and is commensurate with experience.
